Speaker Bios:



PJ Dunn C.C.P. is described as a "critical thinker with a heart for human flourishing." Erica Benites Giese currently serves as the Chief of the Financial Litigation Unit for the Western District of Texas. She is primarily responsible for enforcing the District's criminal restitution judgments and oversees litigation related to the enforcement of those debts owed to victims of crime. This litigation takes place in the criminal case using civil procedure and civil enforcement tools. She also oversees litigation involving foreclosures, condemnation proceedings, student loan cases, and civil judgments. Erica has served in the civil division handling qui tam and defensive cases, in the criminal division as both an Assistant United States Attorney and Chief of the San Antonio and Del Rio Divisions.



U.S. District Judge Alia Moses was born in Eagle Pass, Texas and raised in the small town of Quemado, Texas. President George W. Bush nominated Judge Moses to the United States District Court for the Western District of Texas. On November 18, 2002, Judge Moses took the oath of office as United States District Judge, becoming the first district judge to reside in the Del Rio Division and the first female district judge for the Western District of Texas. Judge Moses is a graduate of Texas Women's University and the University of Texas School of Law. Prior to becoming a federal judge, Judge Moses worked at the Travis County Attorney's Office and served as the Chief of the United States Attorney's office in Del Rio, Texas.



Paula Rosales is the Judge-elect of Dallas County Court at Law #4, who won this bench against an incumbent with 11 points in the Democratic Primary Runoff. She was a City of Dallas Municipal Court Judge and Community Court Judge for five years. During her tenure, she developed and implemented innovative court programs to ensure that justice was accessible to all and not only those who could afford attorneys. She is a former Assistant Dallas County District Attorney representing the State of Texas in various trial and appellate courts, including the Texas Court of Criminal Appeals. Paula has also served her country abroad as a human rights advisor for the United States Department of State -Western Hemisphere Programs.
